These organizations have differing goals and priorities and different workloads and manpower available; therefore if you don't get a satisfactory answer or response from one organization, call another. If you call one of these organizations, you will usually get one of two responses; an immediate conversation with someone about your problem or they will return your call the next work day.

Sometimes they will send you some literature to help explain the current laws and the courts interpretations etc.. Frequently they can simply and efficiently resolve the issue with a phone call or letter to the public school teacher, administrator or school board official (*Consider having contact names, addresses, phone numbers &/or email information available when you call*).
